This is to inform that in light of the restrictions imposed by the government due to the Covid-19 Pandemic situation, our offices were closed/partially closed and we had very limited access to the documents. The Company had suffered massively in this second COVID-19 wave and several employees of our Finance and Accounts team were infected with Covid, few of them were also hospitalized. The Office building had to be forcefully closed as it was declared as a containment Zone.

Presently we are working with negligible staff as few of our employees have still not recovered and we trying to resolve issues to our best from alternate locations as much as possible. We are also facing various other difficulties in providing papers/ documents for query raised by auditors to complete the audit procedure thoroughly.

The Company has not yet completely started its key offices in Kolkata. This has not only impacted our administration and regular accounting operations but completion and closure of annual accounts and consolidation process. Our management is making continuous effort to resume the work/to give access to all the operating systems to make work possible and normal.

In view of the above we request you to kindly allow us time till 14th August, 2021 to file/submit Audited Financial Results for the quarter and year ended 31st March, 2021 pursuant to comply Regulation 33 and 52 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015.

We also request to consider the reason disclosed herein above as compliance with the requirement as per circular no. CIR/CFD/CMD-1/142/2018 dated 19th November, 2018 of informing reason for delay in submission of financial results. We further earnestly submit to condone delay and not initiate any action in this regard since the delay is purely for the reasons beyond our control. The Company shall make its best efforts to comply with the applicable regulation within the time allowed.

Kindly consider our request and grant us the extension for the same.
